INFORMATION FOR EXTRA-ORDINARY GENERAL BODY MEETING (EGM)

Greetings to all Dear Residents,

Last General Body Meeting was held on 12.05.2024. Minutes of this meeting are available on the website of GKIIWA (www.gk2wa.in).

We had proposed to hold an EGM on 14.07.2024. Notice for this meeting was circulated on 22.06.2024 (through inserts in the newspapers & and on the website, giving stipulated notice period of 21 days. This practice for information through inserts in the news papers about AGM and EGM had been in-place for more than 40 years, without any issue/objection so far.

Somehow because of objection by a few residents with regard to the mode of notice (a technical reason only), this scheduled EGM on 14.07.2024 could not be held.

We propose to take care of this minor but critical technical anomaly and shall send the information about the EGM through speed post to about 4000 members, which shall cost to your GKIIWA a sum of about Rs. 80000/- (which could have been used for the other welfare activity for the residents).

Hitherto, we propose to hold the EGM on, Sunday, 13.10.2024

Main agenda points shall be as under:-

1. Proposed Amendments in the Constitution of GKIIWA
2. Proposed Guidelines/Code of Conduct for the Builders

- 3) Subsequently, thereafter, proposed amendments shall be finalized by E.C and circulated again on 22.09.2024, along with the final notice, for the proposed EGM on 13.10.24.
