It gives us immense pleasure in announcing the details of forth coming Elections of the Executive Committee of Greater Kailash II Welfare Association for the term 2024-2026. Details are as under:

1. FINALIZATION OF VOTER'S LIST

For the current election, voters' list frozen as on 29th Feb., 2024 will be the basis. The list has been provided to us by the RWA duly signed by the outgoing General Secretary as per the constitution.

The voters' list is displayed at RWA Office at M-19, Basement, G.K.-2, NEW DELHI, (kindly see Schedule). All resident members of GKIIWA are advised to check their names in voters' list. Any omission or amendments, specifically pointed out in person, within given time schedule, will be addressed and considered by RO / Co-RO. **No corrections or amendments would be entertained beyond the time schedule.**

After the corrections, final voters' list will be displayed, which will be the basis for current election.

2. ELIGIBILITY TO VOTE

- a. All Members, enrolled up to 29th Feb., 2024 as stipulated in the constitution of GKIIWA, having their names in voters' list will be allowed to cast Vote. All Residents wishing to vote have to bring along necessary Document of Proof of Residence and Identity. **Aadhaar Card, Passport, Election I-Card, Property Documents (House Tax Receipt), Driving License bearing the address of G.K.-2 and for newly married person, the validity of residential proof of the spouse and rental agreement for valid members living in rented accommodation in G.K.-2, shall be acceptable.**
- b. He / She should be 18 years of age or above and should not have been declared insolvent by any court of law

3. ELIGIBILITY TO CONTEST

- a. Only Life Members enrolled up to 29th February 2024 as stipulated in the constitution of GKIIWA, and having their names in the voters' list are allowed to contest the GKIIWA election for the term 2024-26.
- b. No Member of GKIIWA who held the same post in GKIIWA Executive Committee for **Two Terms** (for a tenure of four years) can file his/her nomination for that particular post. He / She, however, can file his/her nomination for a different post.
- c. He / She should be 18 years of age or above and should not have been declared insolvent by any court of law.
- d. He / She should have cleared all his/her dues.

4. FILING OF NOMINATION (Kindly see Schedule)

- a. The Contestants would be required to file nomination accompanied by the Proposer and Secunder in person in the GKIIWA Office, as per schedule circulated, along with the necessary documents as a proof of Residence and Identity i. e. **Aadhar Card, Passport, Election-I Card, Property Documents (House Tax Receipt) , Driving License bearing the address of G.K.-2 in Original .**
- b. Contestants, Proposer and Secunder should be life members of the Association without any outstanding dues of the Association. Names of contestant, proposer and secunder should appear in the Voters List.
- c. For the Positions of President, Vice Presidents, General Secretary, Jt. General Secretary & Treasurer, any Resident from any Block could be a Proposer or Secunder.
- d. Contestants for Block Secretary and Block Representatives should have Proposers and Seconders from the same Block.

- e. No proposer or seconder can propose or second for post in excess than number of posts specified in the category. In the eventuality, otherwise, all the nomination/s of the proposer or seconder for that particular post will be held invalid and rejected at the time of scrutiny for preparing list of valid nominations.
- f. No eligible member can contest for more than one post. In case valid nominations are found for a member for more than one post at the time of preparing final list of contestants, post withdrawal, all the nominations in respect of the member would be rejected.
- g. The Candidate will need to sign on the Register maintained by RO / Co-RO along with the Proposer and Secunder at the time of Filing of Nomination
- h. Withdrawal to be submitted personally by the concerned member in a prescribed form within stipulated time.
- i. Alignment to any team needs to be submitted personally by the concerned member in a prescribed form within stipulated time.
- j. Only two nomination papers will be provided to each Valid Member.**
- k. At the time of scrutiny only contestants/ Proposers are allowed to be seated with election committee members and RO / CoRO.**
- l. Contestants are strictly advised to desist from visiting RO / CoRO and members of Election Committee at their Residences for any Election related issue / procedure.

5. VOTING

- a. Voting would be done by secret ballot. Every member present and voting shall have ONE VOTE.
- b. The Voting Time is from **8:00 AM to 3:00 PM**. Entry for the Voters will be **closed by 3:00 PM Sharp**. However, the Voters inside the premises and waiting in the Queue to exercise vote shall be allowed to cast their Vote. **All Voters are requested to reach well within stipulated time before 3:00 PM and not wait till the last moment.**
- c. An indelible Ink mark would be applied on the Left Hand Thumb. The Voters are requested to exit the Voting Area immediately after casting their Vote.
- d. Handicapped and very Senior Voters (80 years and above) would be provided with all possible assistance and given preference for casting their Votes.

6. COUNTING OF BALLOTS AND ANNOUNCEMENT OF RESULTS

- a. On conclusion of voting, the Counting will begin in the presence of two representatives of each Team nominated by their respective Presidential Candidates and authorized by RO/Co-RO. Such representative should not interfere in the process of counting. In case of any dispute, the matter should be brought to the notice of Observer. In any case no contestant will be allowed in the vote counting areas. Upon counting of Votes, the Result will be announced by the RO and Co-RO after satisfactory completion of counting.
- b. In case of tie the result will be decided by draw of lots. Chit/s picked-up will be treated reject.

7. GENERAL

All the contestants shall have to abide by the code of conduct framed by the election committee and rules and regulations of the Greater Kailash II Welfare Association.



We appeal to all the residents and contestants to maintain peace and harmony during the process of elections.




